DOG ELIGIBLE TO ENTER

Open to all dogs at least 1 year of age by the day of the test that are individually registered with the American Kennel Club, recorded in the FSS program, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners program. A dog may enter only once per event. There are two events each day. Each event has an individual event number. If you would like your dog to run twice each day, you must enter and pay for both events each day (AM/PM).

ENTRY FEES

No PRE-entries will be accepted by phone, email, or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

CHECK-IN/ARRIVAL PROCEDURE & CRATING AREAS

There will be a table and set of trial stewards for check-ins and information. When you arrive at our fastcat trials, you will check in your dog when it is your dog's timed block and get checked for lameness and bitches in season. Inspection shall take place prior to any form of wrapping being applied to your dog if you should choose to do so. In the opinion of the inspection committee/stewards, any entry found lame, unfit to compete or in season will be fully refunded. All dogs are to be inspected before each run. In addition, the dog's handicap must be verified at the time of inspection. You will receive a sticker at inspection that will be turned in to the Paddock Master.

**** Aggressive, Sick or Uncontrollable Dogs will be asked to leave with no refund. The field committee reserves the right to bar known aggressive dogs, especially from the event site. ****

The "Run Order" will be based on dogs selected for that time block selected by the exhibitor in their entry. If you have multiple dogs running, we would suggest picking multiple blocks or pair dogs together/space them out. No specific order will be made prior to trial dates. When you are ready to run and it is the time block you chose on your entry -- head to check-in! Please do not arrive early for your run to prevent conflicts and excessive waiting times. If a dog is late for their run time or you have a conflict such as competing in other events on the property, the check-in steward's will run your dog as soon as openings are available to avoid inconveniencing those that arrived as scheduled.

Dogs should be crated far away from the fastcat track. Designated crating areas will be marked day of show. We recommend bringing covering/canopies for your comfort as well as your dog's. You may also opt to crate from your cars. Waiting in line for your run, we request you to be aware & in-control of your dogs. Control of dogs is strictly enforced! All dogs must always remain on leash except when running the course.

ADDITIONAL SITE INFORMATION

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal trashcans will be available at various locations around the show grounds. Please don't let us lose our show site because of not picking up dog poop. We want to be respectful of the Posey County Fairgrounds! See our Treasurer the day of show for a fun incentive to keeping our show site clean! Exhibitors should also follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Basic Info about AKC FastCat

Fast CAT Test is a timed straight 100-yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner. Dogs run singularly. (One dog at a time.)

How are Fast CAT Points and Titles Awarded?

- The dog's time to complete the 100-yard dash is converted into MPH. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers. You can find out your dog's handicap below!
 - 18 inches or greater = handicap of 1.0
 - 12 inches to less than 18 inches = handicap of 1.5
 - Below 12 inches = handicap of 2.0
- Points = MPH multiplied by the dog's handicap

Fast CAT titles are suffix titles earned at designated milestones.

- BCAT = 150 points
- DCAT = 500 points
- FCAT = 1,000 points
- FCAT2..3..4...5 = every additional 500 points

The top 20 fastest dogs by breeds are published on the AKC website! Check it out!

SAFETY, BEHAVIOR & LIABILITY

The safety of the dog is our primary concern. By entering this trials, exhibitors acknowledge that they are familiar with the rules and regulations of this trial, and that their dogs are familiar with and able to perform all tasks within safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Evansville Obedience Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Evansville Obedience Club has the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Evansville Obedience Club or any official thereof.

Safety is of the utmost importance. It is the responsibility of the event committee to ensure the safety of the course, equipment and conduct of those involved with the event. It is recommended that the event committee run a test dog prior to the start of the event to ensure that the equipment functions properly, and all personnel understand their jobs. Prior to moving the lure to position it for the start, the lure operator shall announce "hold your dogs" to caution owners.

Collars, Leashes, and Harnesses. Dogs may wear any collar except a choker collar, a harness, a collar with prongs, or an electronic training collar. The collar should be snug to minimize the chances of getting hung up on something during the run. Owners should be aware that there is a chance that tags hanging from the collar could become entangled on something during the run. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility for the safety of the dog with regards to the dog's collar and paraphernalia on the dog.

REFUNDS

If a Fast cat Trial event in this premium is cancelled, the Evansville Obedience Club will contact any preregistered entrants. The Evansville Obedience Club will communicate the change to any potential entrants by the method which they originally advertised to those potential entrants.

If the Evansville Obedience Club cancels their Fast cat trials, preregistered entrants will be given a refund for their entry fees. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical conditions are not eligible for a refund. Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Releasers & Catchers Info

Each handler is responsible for arranging to have both a releaser AND a catcher available during each of their dogs' runs. The Club may provide volunteers to assist with releasing or catching well-mannered dogs but is not obligated to do so for every dog. When this assistance is available, it is strictly a courtesy, and the volunteers accept no responsibility for any actions or consequences. **COME PREPARED!!!**

Fun Runs

FUN RUNS (PRACTICE/INTRODUCTION RUNS): Fun Runs may be conducted, time and conditions permitting in between registered runs, at the end of official runs on each day, except the final day of the event. These are "unofficial runs" and the results will not be recorded or reported to AKC and will not count toward title progression or rankings. Ribbons will be provided for Fun Runs. The number of Fun Runs allowed will be determined by the Event Committee onsite. This is to ensure the safety and comfort of all animals, handlers and workers / volunteers onsite. There will be a fee of \$10.00 per run, which is non-refundable, regardless of the success / failure of the dog to run, or the results. The Event Committee reserves the right to allow fun runs at other times, or to cancel fun runs at any time, at their sole discretion.

Field Conditions & Runout Info

The field is reasonably flat, level and mowed. The running area is approximately 150 yards long x 6 yards wide, with a cloth/plastic type fencing provided by Lucky Dog Coursing. The release line is ten feet behind the starting line. The course is 100 yards long with finish line timers (electronic or manual) and an appropriate AKC prescribed run-out area. Handlers may not walk the course during or before their dog is released for the actual test. (New rule as of November 2022.) Lucky Dog Coursing will provide enough room for a safe run-out area. It is recommended that an owner or someone familiar with the dog be at the finish to catch the dog once the course is completed. The Club will attempt to help exhibitors at the end of the course to collect the dogs as a courtesy but are not required. Please exit the course as soon as your dog is leashed.
